The Correspondent, Bapatla High School, Bapatla, Bapatla District is informed that Renewal of Recognition has been accorded to classes VI to X (EM) during the academic year 2022-2023 without aid now or in future in the reference (7) read above. The Deputy Educational Officer, Bapatla, Bapatla District has recommended for Renewal of Recognition to classes VI to X (EM) for the period from 2023-2024 to 2030-2031 without aid now or in future vide reference (12) read above. The District Educational Officer, Bapatla has verified the application for Renewal of Recognition to classes VI to X (EM) for the period from 2023-2024 to 2030- 2031 without aid now or in future with reference to the Inspection Report of the Inspecting Officer and also with reference to the conditions laid down in the reference (13) read above.

After careful examination of the proposals and the conditions prescribed in G.O.Ms.No.1 Edn., dated 1 1-1994, G.O.Ms.No.41 Edn, dated 11-05-2006, G.O.Ms.No. 74 Education, dated 11-09-2006 and G.O.Ms.No.38 Edn., dated 22-04-2023 and as per the instructions issued by the Government / Commissioner of School Education, Andhra Pradesh, Amaravati in the references (1) to (6), (8) and (14) read above, the Regional Joint Director of School Education, Guntur is hereby accords

Renewal of Recognition to classes VI to X (EM) for a period of eight (8) years from 2023-2024 to 2030-2031 without aid now or in future in respect of Bapatla High School, Bapatla, Bapatla District However, by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide by the instructions, rules and regulations made by the Government or authorized officer from time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff within the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the staff pattern.
6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing Body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D, E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit a proposal for Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal of recognition.
14. The Renewal of Recognition now given is purely on a temporary basis and is subject to the reports of the State Level Inspection and Vigilance Committee fulfilling all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Department and Renewal the Fire Certificate from time to time without fail and submit the same to this officer through the Deputy Educational Officer, Bapatla, Bapatla District and the District Educational Officer, Bapatla.
16. The Management is requested to Renewal the Vehicle Fitness Certificate every year from the concerned authorities without fail and submits the same to the concerned Deputy Educational Officer.
17. The management should improve the strength and maintain minimum economic strength as per the rules. Further, the management should obtain NOC from the Traffic Police and also

obtain Structural Soundness Certificate and Sanitary Certificate from the competent authority every year and submit the same to the District Educational Officer, Bapatla through the Deputy Educational Officer concerned.

Further, the managing committee of the school is requested to fulfill all the requirements to cope up with the needs of the institution at the latest before submitting the application for Renewal of Recognition for the year 2031-2032.

Receipt of these proceedings should be acknowledged.
